8. All children should be picked up promptly at the end of the party.
9. Club 1 Fitness is not responsible for lost, stolen, or damaged personal items.
10. Rental groups shall be financial accountable for any unforeseen expenses incurred by Club 1 Fitness resulting from misuse or negligence on the part of the rental group and/or guest.
